



2020 CHRISTIAN COUNTY Community Health Assessment & Improvement Plan



A Brief History

In 2012, the Christian County Health Department partnered with over 40 community partners including law enforcement, schools, medical providers, civic organizations, mental health facilities, etc., and conducted the community's first Community Health Assessment. The group identified key issues to address over the next 4 years and many positive changes took place in the Christian County community including:

- City Smoking Ordinance
- Hopkinsville Greenway System
- Farmer's Market
- Hopkinsville Transit

In 2016, the Christian County Health Department gathered community members once again to evaluate the previous 4 years and conduct a new assessment to address any additional issues or changes. New health related issues were identified and a new Community Health Improvement Plan was implemented. The group formally established themselves as the Christian County Wellness Coalition and achieved the following between 2016 and 2020:

- Significant improvements in the County Health Rankings
- Hopkinsville Greenway Extension
- New line added to the Hopkinsville Transit System.

In 2020, the Christian County Wellness Coalition reconvened and began the 2020 Community Health Assessment process. Over 40 community members gathered to conduct the following assessments in the MAPP process to garner feedback about our community's health.

- 1. Community Themes and Strengths Assessment
- 2. Local Public Health System Assessment
- 3. Community Health Status Assessment
- 4. Forces of Change Assessment

1) Community Themes and Strengths Assessment

The Community Themes and Strengths Assessment provides a deep understanding of the issues that residents feel are important by answering the questions: "What is important to our community?" "How is quality of life perceived in our community?" and "What assets do we have that can be used to improve community health?

The Community Perception Survey gauges community interest and opinion by detailed questions surrounding quality of life attributes of Hopkinsville and greater Christian County.

Below are the results of the 2017-2018 survey distributed by the Chamber of Commerce and completed by 305 Christian County residents.







Age Group









Do you feel like there are enough job opportunities in Christian County in your career field?




Walking in downtown Hopkinsville


Walking alone in my neighborhood


Walking in neighborhood parks




Walking on the Greenway




Have you been a victim of *property* crime in Christian County within the last 5 years?


Have you been a victim of *violent* crime in Christian County within the last 5 years?









2) Local Public Health System Assessment

The Local Public Health System Assessment (LPHSA) focuses on all of the organizations and entities that contribute to the public"s health. The LPHSA answers the questions: "What are the components, activities, competencies, and capacities of our local public health system?" and "How are the Essential Services being provided to our community?"

3) Forces of Change Assessment

The Forces of Change Assessment focuses on identifying forces such as legislation, technology, and other impending changes that affect the context in which the community and its public health system operate. This answers the questions: "What is occurring or might occur that affects the health of our community or the local public health system?" and "What specific threats or opportunities are generated by these occurrences?"

The Community Health Status Assessment identifies priority community health and quality of life issues. Questions answered include: "How healthy are our residents?" and "What does the health status of our community look like?"



After conducting the 4 MAPP assessments and studying the results, the Christian County Wellness Coalition identified the following health issues that needed to be addressed in our community:



Contributing Factors



Substance Abuse | Smoking

- Severe additions
- Drug sales generates income.
- Peer Pressure
- Pain pills sometimes over-prescribed by physicians
- Family History
- Vaping popular among youth
- 2nd & 3rd hand smoke exposure
- Lack of education and research on vaping
- Quitting smoking contributes to weight gain



Sexual Health

- Lack of role models
- Individuals scared to ask questions
- Breakdown of the family structure
- Lack of emotional support
- Living in the Bible Belt (Abstinence Only)
- Peer Pressure
- Little discussion about prevention
- Unsupervised youth
- Lack of education



Chronic Disease

- High Smoking Rates (KY has one of the highest smoking rates)
- 2nd & 3rd hand smoke exposure
- Lack of education and research on vaping
- Quitting smoking contributes to weight gain
- Lack of physical activity
- Low intake of fruit and vegetables/lack of access to healthy foods/food deserts
- Limited physical education in schools
- Lack of education about healthy eating
- Professionals too busy to take time and care for ourselves
- Family culture of bad eating habits
- Lack of motivation
- Unhealthy foods readily available
- High poverty rates due to family income, poor graduation rates, unemployment, etc.



Mental Health

- Shortage of services and difficult to access
- Wide range of mental health issues.
- Lack of education at earlier ages regarding coping mechanisms when dealing with emotions.
- Not a clear definition regarding what constitutes a mentally unhealthy day in the data collected.
- Many mental illness caused by drug abuse.



Multi-Generational Wellness: Maternal Child & Elder Care

- Lack of funding for elder care programs
- Lack of education regarding resources
- Lack of trustworthy adult providers
- Lack of access to dental care
- Medicare doesn't cover dental costs
- Limited dental providers who take medicaid
- Babies born with drug addictions
- Lack of education within the Amish population
- High rates of teen mothers



Access to Health Care

- High insurance deductibles
- ER visits are cheaper
- Inappropriate use of ambulance and EMS services
- Lack of availability of specialists
- High medicaid rates
- Ft. Campbell skews Christian County provider ratio rates
- High poverty rates due to family income, poor graduation rates, high unemployment, etc.

After dissecting the issues identified, the team was able to condense the 10-item list into a list of 6 top health priorities to address over the next 4 years. **Community Health Improvement Plan
